
SCHOOL UNIFORM POLICY

1. Introduction

- 1.1. It is our policy that all children should wear school uniform when attending school, or when participating in a school-organised event outside normal school hours. We provide a complete list of the items needed for school uniform in our school prospectus.

2. Aims and Objectives

- 2.1. Our policy is based on the notion that a school uniform:
- promotes a sense of pride in the school
 - engenders a feeling of community and belonging
 - is practical and smart
 - identifies the children with the school
 - is not distracting in class (as fashion clothes might be)
 - makes children feel equal to their peers in terms of appearance
 - is regarded as suitable, and good value for money, by most parents
 - has been designed with health and safety in mind

3. Jewellery

- 3.1. On health and safety grounds, we do not allow children to wear jewellery in our school. The exceptions to this rule are watches, we ask the children to remove them during PE / Games or physical activities. Earrings are not permitted.

4. Extreme Haircuts

- 4.1. The school does not permit children to have haircuts that could serve as a distraction to other children. School will always review this with parents / carers.

5. Footwear

- 5.1. The school wants all children to grow into healthy adults. We believe that it is dangerous for children to wear shoes with platform soles or high heels in school, so we do not allow this. Neither do we allow children to wear trainers inside school; these are appropriate for sport or as leisurewear and may be worn at playtimes/lunchtimes. We require all children to wear the black shoes as described in the uniform list.

6. The Role of Parents

- 6.1. We ask all parents who send their children to our school to support the school uniform policy. We believe that parents have a duty to send their children to school correctly dressed and ready for their daily schoolwork. Parents should ensure that their child has the correct uniform, and that it is clean and in good condition.
- 6.2. If any parent would like the school to modify the uniform policy, they should make representation, in the first instance, to the head of school. The school welcomes children from all backgrounds and faith communities. If there are serious reasons (e.g. religious objections), why parents want their child to wear clothes that differ from the school uniform, the school will look sympathetically at such requests. Similarly, should an item of school uniform prove problematic for a pupil with disabilities, then parents are invited to draw this to the attention of the headteacher. Reasonable allowances may be made to support pupils with disabilities. The school will not permit requests that are adjudged by the headteacher to put the health and safety of pupils at risk.
- 6.3. The school periodically consults with parents on the Parent Voice Working Group concerning this policy and gathers their views.

7. The Role of Governors

- 7.1. The governing body supports the head of school in implementing the school uniform policy. It considers all representations from parents regarding this policy, and liaises with the headteacher to ensure that the policy is implemented fairly and with sensitivity.
- 7.2. It is the governors' responsibility to ensure that the school uniform meets all national regulations concerning equal opportunities, and that our school uniform policy is consistent with our policy on equal opportunities.
- 7.3. Governors ensure that the school uniform policy helps children to dress sensibly, in clothing that is hardwearing, safe and practical.

8. Monitoring and Review

- 8.1. When monitoring this policy, through its committee work, the governing body will:
- consider with the head of school any requests from parents for individual children to have special dispensations; and
 - require the head of school to report to the governors on the way in which the policy is being implemented.
- 8.2. This policy will be reviewed by the governing body every two years, or earlier if considered necessary.
